# <u>一般條款 MAI</u>N TERMS

- 1 本合約由智尚商務國際有限公司(服務供應商)提供,並由申請虛擬辦公室服務的公司(客戶)同意,雙方共同履行合約內所載的條款及細則。
  - This agreement is offered by Brilliant Business Centre Limited (Service Provider) and accepted by the applicant of virtual office service (Customer), both executing those terms and conditions stated in this agreement.
- 2 本協議受中華人民共和國香港特別行政區法律管轄,並按香港特別行政區法律闡釋,服務提供者及客戶均同意接受香港特別行政 區法院的專屬管轄權所管轄。 This agreement shall be governed by and construed in accordance with the laws of the Hong Kong Special Administrative Region ("HKSAR") and the parties hereby irrevocably submit to the non-exclusive jurisdiction of the Courts of the HKSAR.
